

## OFFICIAL 2016 JRGC 52-GUN WEEKLY RAFFLE RULES (Revised) 09/30/2016

The 1<sup>st</sup> Annual "JRG 52-Gun Weekly Raffle" is being sponsored by the **Jasper Rifle and Gun Club, Inc.**, a non-profit corporation, with a determination letter from the IRS as a tax exempt 501(c)(7) organization. This Annual Raffle is being conducted under License 141596 from the Indiana Gaming Commission.

- (1) A maximum of 1,000 raffle numbers will be sold. Numbers 000 through 999, no additional numbers will be added. All unsold raffle numbers become property of the Jasper Rifle and Gun Club.
- (2) A donation of \$52.00 per raffle number is required; and can only be purchased using the JRGC 52-Gun Weekly Raffle application available from our web site, a Jasper Rifle and Gun Club member or participating vendors. All donations must be paid prior to the drawing in order to be included in the raffle. All raffle number sales are final and are non-refundable. First come, first served. In the event a raffle application is received after the last raffle number is sold, the donation will be returned.
- (3) Participants will NOT be able to pick their raffle numbers. Participants will be assigned unique, shuffled, non-sequential raffle numbers, from 000 through 999. Raffle numbers will be mailed by United States Postal Service to the participant's address as provided on the raffle application.
- (4) Each raffle number purchased will qualify as one entry into the weekly raffle drawing. Winners are not removed from the weekly raffle drawing and remain eligible to win more than once. Participant's raffle number will be valid for all 52 weekly raffle drawings.
- (5) Firearms will be assigned to the weekly raffle drawing dates and will be listed on our web site.
- (6) The commencement date for the raffle will be the first Wednesday after ALL raffle numbers are sold, and will be announced on the Jasper Rifle and Gun Club website as well as our Facebook page.
- (7) If all raffle numbers are not sold by 01/01/2017 there will be a (1) firearm awarded for every 19 raffle numbers sold (Example: If 855 raffle numbers are sold 45 firearms will be awarded). In the event that a raffle number is drawn that had not been sold, the raffle will continue to next week's raffle drawing until all firearms are awarded. The un-awarded firearm will then be added to the bottom of the prize list.
- (8) If any raffle numbers are unsold, Jasper Rifle and Gun Club reserves the right to sell any unsold raffle numbers for a future raffle date at a cost equal to the number of remaining weekly drawings times \$1 plus a \$5 premium.
- (9) By obtaining a raffle number, participant attest that they are a law abiding citizen of good moral character, may legally possess any firearm won, have intention of using the firearm only in a safe and legal manner, and will or have already obtained instruction on the safe use and operation of any firearm won.
- (10) Raffle numbers will be drawn each Wednesday at the Jasper Rifle and Gun Club, located at 2188 E. Gun Club Road in Jasper. Drawing time is approximately 5:15pm and raffle participants are welcome to attend.
- (11) Winners will be listed each week on the Jasper Rifle and Gun Club's Facebook page and on our website at [www.jaspergunclub.com](http://www.jaspergunclub.com).
- (12) Notification will be sent to the winner and firearm vendor, listing the winner's name and address, raffle drawing date and winning number drawn, location of the vendor, the firearm won, and expiration date of redemption.

(13) Three (3) attempts will be made to notify the winner based on the information provided by the participant, (telephone, email and USPS). It is the sole responsibility of the participant to notify the Jasper Rifle and Gun Club of any change in address or phone number.

(14) All prizes must be claimed within 30 days of the drawing date. Any prize not claimed within 30 days will become the property of the Jasper Rifle and Gun Club for future raffles.

(15) Winners may accept either (1) the prize as assigned to that week's draw, or (2) receive a discounted gift certificate for the value of the prize assigned to that week's draw. Depending on winner's option, vendor may need to order the prize assigned for that week's draw for redemption. Please allow ample time for delivery.

(16) The raffle number winner must provide proof of identification, must be 18 years of age or older for long guns, 21 years of age or older for handguns, a US resident, and must be capable of passing all applicable background checks.

(17) Any raffle winner who does not meet Federal, State, local or other legal requirements to purchase, own or possess the awarded prize, or is unable to pass the applicable background check; winner will receive in lieu of the prize a discounted gift certificate for the value of the prize assigned to that week's draw.

(18) Firearms are not transferable. The participant designated by the winning raffle number must claim the firearm. No straw purchases allowed.

(19) Jasper Rifle and Gun Club reserves the right to make substitutions depending on availability or discontinuance of firearms. Any substitutions that have to be made will be replaced by a prize of equal or greater value.

(20) Any taxes on prizes or gift certificates are the sole responsibility of winners.

(21) At no time will Jasper Rifle and Gun Club take possession of any of the firearms involved in this raffle. All firearm transfers will be done through a Federal Firearms Licensed (FFL) dealer only, and all applicable Federal, State and local laws will apply.

(22) In the event winners need or wish to have the awarded firearm(s) transferred to their local FFL dealer, shipping and any other additional costs involved with the transfer will be the responsibility of the winner, and arrangements must be made directly between the winner and participating FFL dealer.

(23) The Jasper Rifle and Gun Club makes no warranties regarding any firearms and no representations regarding suitability of purpose for any firearm. Winners are to deal directly with the manufacturer or FFL dealer in the event of problems.

(24) The liability of Jasper Rifle and Gun Club and its Officers, Directors and Members is limited to the purchase price of the raffle number purchased.

(25) Raffle is void where prohibited.
